As I begin my year of service our organization must navigate the ambiguities related to the historic dismantling of ACA and ASCA in a manner that keeps the needs of our members at the forefront. As conveyed by Margaret Weatley, "The things we fear most in organizations--fluctuations, disturbances, imbalances--are the primary sources of creativity." In this regard, I am excited to explore new opportunities and strategic partnerships that can grow our organization and expand our members' services and resources. Beyond organizational considerations, I also plan to sharpen our focus in 3 important areas.

- Completed literature reviews
- Qualitative and Quantitative research studies
- Master's thesis/ Doctoral dissertation
- Counseling interventions/techniques

We have an exciting legislative season ahead of us! At a state level, we have a new governor coming into office and 1/3 of the Tennessee General Assembly will be brand new. At a federal level, 1 of our 2 Senators will be new with Bob Corker retiring and all 9 of our House of Representatives will be voted on. We're looking carefully at policies around mental health, substance use disorders, education, and the justice system. Do your homework and vote for someone who stands for what you believe in when it comes to policies like these and other issues that are important to you.

# **Human Rights Committee**

Voting = Human Rights

The 2018 mid-term elections are near. With all of the buzz surrounding the approaching elections, I remember lyrics from Bob Dyan's song, "The Times They Are Changin".

Come senators, congressmen
Please heed the call

Don't stand in the doorway
Don't block up the hall
For he that gets hurt
Will be he who has stalled
There's a battle outside
And it is ragin'.
It'll soon shake your windows
And rattle your walls
For the times they are a-changin'.

The lyrics remind me not so much that times are a changing, but that times *can* change. And change can happen through voting. Now, to be clear, this article will not be a partisan attack; instead, I intend to explain the connection between the importance of exercising your civic right of voting and the counseling profession's unique opportunities to advocate for clients, providing you with resources to help you make informed voting decisions.

In 2016, the counseling community lobbied Tennessee's Legislature to defeat a bill allowing counselors to refuse service based on the "goals, outcomes, or behaviors that conflict with the sincerely held principles of the counselor or therapist." Essentially, the bill allowed counselors to discriminate against clients who do not share their belief systems. Leading up to the vote, both the American Counseling Association (ACA) and Tennessee Counseling Association (TCA) lobbied against the bill. While the outcome was not the desired result by both organizations, we, as a membership body, *can* still effect change.

Change comes from advocacy. ACA's Code of Ethics calls for counselors to advocate for clients on the individual, group, institutional, and societal levels when clients' access to services and/or growth as humans is impaired (ACA, 2014). In thinking of advocating, some envision picket signs, marches, or sit-ins. Yes, all are forms peacefully advocating, yet advocating is also making your voice heard in the voting booth.

Change also comes from reliable, fact-based information. That being said, the internet is filled with vast non-partisan resources where you, as an informed voter, can access donor information and determine if a candidate's professional and personal values align with your own.

Lastly, change comes from actually voting. In Knox County, where I reside, earlier voting starts October 17<sup>th</sup> and runs through November 1<sup>st</sup>, with nation-wide Election Day commencing on November 6<sup>th</sup>. I personally have found early voting beneficial with my hectic schedule. During early voting, there is often no wait and the location is close to my home. You can find specific voting information in your area by visiting the Tennessee Secretary of State's website, <a href="https://sos.tn.gov/">https://sos.tn.gov/</a>.

In concluding, in my family, and maybe yours, there's saying, "if you don't vote, you can't complain." As I type this call to action, those words bounce in my head and make me even more resolute in voting this November. So, go vote and have your voice heard.
